
UP NEXT: 4th of July Boat Parade will be on July 4th 7:30pm – no conflict with PCC Freedom Fest on July 3rd or

Lake Management

Summer is almost upon us, and we've been blessed with some beautiful days on the lake. Whether you like swimming, boating, kayaking or paddle-boarding, the lake is calling.

NC Lake Management has already been on the lake spraying for grasses in the shallow Horse Creek Cove. They plan on spraying the perimeter via boat the beginning of June for grasses and algae. No notification to turn off your lake-fed sprinkler system is required for this spraying. In August or September, spraying will be for hydrilla, and we'll provide notice for home-owners to stop using lake water for irrigation. The cost for weed treatment is split between the Resort and the lake-front property owners. Invoices will be sent out in July by the Resort and are not part of the club dues. If you're a lake-front owner, your voluntary participation will ensure that the lake is pristine for our many recreational activities. If anyone has an issue with grasses, algae or weeds around their dock or bulkhead, let me know, and I'll have it treated. My contact information is in the directory.

I hope the summer is great for all!

Government

The spring construction season, coupled with all the recent heavy rain, has resulted in sediment and stormwater running off clear-cut construction sites around the lake onto adjoining properties, and into the lake itself. Some photos of the damage from the May 9-12 weather can be seen here:





Responsibility for containing sediment and stormwater on a construction site rests with the contractor. In fact, no building permit is to be issued until the contractor has delivered to the Village an Erosion and Sedimentation Control Plan, approved by the Department of Environmental Quality. The Village does not enforce this requirement on contractors even though it appears in several places in the PDO, and the Pinehurst Municipal Code. I have contacted the task force that is reviewing and updating the PDO, pointed this shortcoming out to them, and hopefully they will include a solution as part of their finished product.

In the meantime, on the good news front, know that Mike Apke, Pinehurst Service Director is responsive and helpful when incidents like this occur, even though, strictly speaking, it's not his job. His number is 910-295-5021. In addition, Penny Markle is the staff person assigned to Moore County by the Department of Environmental Quality, and she takes these instances of property damage and pollution seriously. She can be reached at penny.markle@deq.gov.

Stopping these problems before they can occur is obviously the solution we're looking for. Everyone who has experienced something like this gets angry and frustrated. Hopefully this new round of trouble will energize the Pinehurst staff to make a stronger effort.

Frustrated by a recurring theme of "there's nothing we can do?" Then get up and volunteer to serve on one of the many Pinehurst Boards and Commissions and have a frontline opportunity to come up with a solution! As it happens, the Village is looking for a few good people on important boards, commissions, and committees. I can say from personal experience that, not long ago, service on a Pinehurst board or committee was largely a thankless job. But now, instead of getting talked at (and down to), there is robust dialog and exchange of ideas. Citizens are being listened to, and volunteer service gives you a feeling of making a difference. From the Archives - Diamondhead in Focus

Early 2025 saw a section of Diamondhead Drive South repaved, repainted and even re-named at one point!!





While the repaving time may have been inconvenient, it's all relative in the eyes of those LPA members who were among the early builders and residents along Diamondhead and remember it as a dirt road until around 1985.



To share a little history: In 1982, Citibank obtained the Pinehurst Resort, including the lake, from the bankrupt Diamondhead Corporation, and subsequently sold all of Pinehurst to ClubCorp in 1984. Shortly thereafter, the lake was christened Lake Pinehurst and Diamondhead Drive South was paved
